SECTION 6 – ACCIDENTAL RELEASE MEASURES

Emergency Procedures Minor spills do not normally need any special clean-up measures. In the event of a major spill, prevent spillage from entering drains or water-courses. For large spills, or tank rupture, consider initial evacuation distance of 200 metres in all directions. Stop leak if safe to do so. Remove all ignition sources. If available, use water spray to disperse vapour. Wear appropriate protective equipment as in section 8 below to prevent skin and eye contamination.
